



DC Department of Corrections Operating Budget and Net Expenditure in million dollars







DOC FY 2024 Budget by Service







FY 2024 Grade and Function Distribution of DOC Employees








DC Department of Corrections Average Daily Population by Fiscal Year for the Central Detention Facility (CDF) and DOC Total






DC Department of Corrections Average Daily Population by Calendar Year for the Central Detention Facility (CDF) and DOC Total




Average Daily Population by Sex and Facility for Fiscal Year 2024







Average Daily Population by Sex and Facility for Calendar Year 2023


Admission Types for FY 2024 Women Intakes






Intakes and Releases for Men by Fiscal Year

Admission Types for FY 2024 Men Intakes





CY2024 Men Intakes by Admission






DOC Intakes in FY 2024 by Primary Language Spoken




Non-English Speakers Primary Languages in FY 2024

Spanish, Amharic, and French were the most frequently declared non-English primary languages among new intakes at DOC in FY 2024.





The majority of DOC residents, 91.79%, are English speakers; 5.04% declare a non-English primary language and data is unavailable for the remaining intakes—primarily because they were released before the intake process was completed.



In Fiscal Year 2024, the majority of DOC intakes, 42.64%, were of Christian faiths; 34.55% were of Islamic faiths; 2.46% were of other faiths; 3.17% were Jewish; and 14.60% had no faith declared.

Of those professing Christian faiths, the majority, 76.89%, claimed to be Christian; of those professing Islamic faiths, the majority, 73.34%, claimed to be Sunni Muslim.







Christian Faiths Professed by Intakes in FY 2024




DOC Residents in Custody by Race, Sex and Education


The majority of DOC's inmates are men. Women comprise under 6% of the population.






Over half of all men in custody were 18 to 40 years old. The average age of men in custody was 35 years.

About 57.67% men in custody were unemployed at the time of incarceration. About 39.4% were employed and another 2.31% were employed part time.







About 40.59% of men in custody had stayed less than three months. About 38.53% stayed between three months and one year while 20.89% stayed more than one year. The median length of stay (LOS) for men in custody was 121 days. (Half the men in custody had been in custody less than 121 days.)


Average LOS for Men by Inmate Status


Most Serious Active Charge for Men in Custody



Those charged with

Homicide/Conspiracy/Kidnapping stayed the longest on average (1.8 years); followed by those charged with Writ/US Witness (1.4 years); followed by those with In-Transit USMS/USDC commitments (1.2 years). The average length of stay for men in custody was 278 days. 8.5% of men in custody were USMS/USDC commitments with unspecified charges. Those charged with assault, aggravated assault, domestic violence; homicide, conspiracy, or kidnapping; , carjacking or first degree burglary; weapons; parole or release violations; arson; and property crimes accounted for the most serious offenses of 76.21% of men in custody. 62.74% of men in custody were charged with a violent or dangerous offense per DC Code 22 Section 4501.







About 63.3% of women in custody were unemployed at the time of incarceration. About 29.7% were employed and another 2.97% were employed part time.








About 59.41% of women in custody had stayed less than three months. About 32.67% stayed between three months and one year while 7.92% stayed more than one year. The median length of stay (LOS) for women in custody was 61 days. (Half the women in custody had been in custody less than 61 days.)

About 61.39% of women in custody had unresolved charges that were either felonies (PF) or misdemeanors (PM). 5.94% of women in custody were held for the USMS (TR) and had stayed about 1 year and 10 months on average, the longest of all. Those charged as parole violators (PV) were 2.97% of the women in custody. Those charged with sentenced felony (SF) charges made up 6.93% of the women in custody. Those charged with sentenced misdemeanor (SM) charges made up 18.81% of the women in custody. The remaining 1.98% were for other (OT) charges.


Average LOS for Women by Inmate Status










Women charged with assault, aggravated assault, or domestic violence as the most serious offense were 40.82% of all women in custody. 4.06% of women in custody were USMS/USDC commitments with unspecified charges. Those charged with assault, domestic violence, homicide, conspiracy, or kidnapping; arson or property crimes; and robbery, carjacking or first degree burglar accounted for the most serious offenses of 78.57% of women in custody. 66.33% of women in custody were charged with a violent or dangerous offense per DC Code 22 Section 4501.


Those with In-Transit USMS/USDC commitments stayed the longest on average (2.1 years), followed by those charged with Drug Offenses (1.8 years), then those charged with Trade and Tarriff Violations (6.8 months). The average length of stay for women in custody was 130 days.





FY 2024 Releases by LOS for Men




The average length of stay to release for men was 108.5 days. Half of men who were released stayed fewer than 26.7 days, the median length of stay to release.

Of men who were released, 60.07% were released to the community. Another 21.25% were removed by the USMS to Northern Neck, USMS to federal facilities, or USMS GB. 14.63% were removed by all other jurisdictions.






FY 2024 Releases by LOS for Women




CY 2023 Releases by LOS for Men









FY 2023 Reincarceration Rate


Recidivism Rate for DOC Intakes FY2023 Based on intake data from October 1, 2023 to September 30, 2023
