EMPLOYEE OF THE MONTH: MARCH 2005



Senior Correctional Officer **Wayne Taylor** was selected as the Employee of the Month for March 2005. Corporal Taylor joined the Department of Corrections in 1990 and is currently assigned to the Male Receiving and Discharge Unit on the number two shift. He is responsible for processing new intakes and court returns into the facility, and for searching each inmate and their property.

By initiating aggressive searches, Cpl. Taylor has, on numerous occasions, prevented contraband from entering his post. In July 2004, he encountered an inmate attempting to enter the facility with a walking cane that disguised an 18-inch blade sharpened to a point. Cpl. Taylor's focused performance of his duties kept the dangerous weapon out of the facility.

"Cpl. Taylor is level headed and always uses good common sense," said Captain William Burns. "He is very conscientious. Because of his alertness, he resolves most of the conflicts before they get out of hand." In presenting Cpl. Taylor with his award, Interim Director, S. Elwood York, Jr. praised him as a "highly competent officer who performs his duties with cautious zeal, always giving his best effort."



This month we profile and applaud three significant and highly effective personalities who keep this DOC organization running successfully.

Mr./Ms. Correctional Employee

This personality works in a correctional facility. Each individual who holds this title has a vested interest in maintaining the security and safety of the facility. All staff in the DC DOC, no matter what their job specialty, are correctional workers <u>first</u> and specialists in a particular occupational area <u>second</u>. Under this concept, all staff members are provided a common base of training in fundamental correctional skills, such as accountability procedures, key control, searches, and other tasks.

Mr./Ms. Senior Correctional Employee

This person is an employee normally assigned to the most responsible line assignments within a correctional facility and throughout the agency, such as the control center, entrance posts, high security, correspondence unit, and the records office. This personality may serve as the officer in charge of living quarters for a specific group of quarters, or the team leader with a particular unit of the agency. The primary responsibility for some includes orienting and supervising new inmates and supervising the disposition of personal property and funds of newly committed inmates. Others are assigned to head up particular projects and offer guidance to team members to assure that projects are completed successfully and in a timely manner.

Mr./Ms. Supervisory Correctional Employee

The third personality to be spotlighted this month is the supervisory correctional employee. This person is responsible for overseeing the main work shifts for security, professional and administrative staff. They may also be responsible for an area of the DOC such as special housing, large recreation areas, public affairs, or information technology. Although paperwork is a vital part of the supervisory correctional employee's responsibility, they are most effective out of the office among the employees and the inmate population.

SALLIE D. THOMAS MOVES TO A NEW OFFICE AND NEW ASSIGNMENT

Sallie D. Thomas, who joined the Department of Corrections in May 2000 as the Administrative Specialist Supervisor to the Director, has been appointed as Acting Executive Assistant.

In this position, Ms. Thomas serves on behalf of the Interim Director as liaison to the Executive Staff, Office of the Mayor, community groups and criminal justice partners to ensure the appropriate delivery of services reflecting the best image of the agency. Prior to joining the Department of Corrections, Ms. Thomas served 28 years as a state lobbyist for a Fortune 500 company. She was involved in various legislations that resulted in significant savings for the company.
