Many DOC residents, 91.53%, are English speakers; 5.40% declare a non-English primary language and data is unavailable for the remaining intakesprimarily because they were released before the intake process was completed.

Spanish, Arabic, Korean, French, and Amharic were the most frequently declared non-English primary languages among new intakes at DOC in FY 2023.

In Fiscal Year 2023 Q3 the majority of DOC intakes, 41.17%, were of Christian faiths; 36.16% were of Islamic faiths; 2.15% were of other faiths; 3.52% were Jewish; and 14.32% had no faith declared.

Of those professing Christian faiths, the majority, 72.25%, claimed to be Christian; of those professing Islamic faiths, the majority, 80.31%, claimed to be Sunni Muslim.

Length of Stay (LOS) for Men in Custody

LOS Distribution for Men in Custody



Almost half of all men in custody (49.43%) had unresolved legal matters that were either felony charges (PF) or misdemeanor charges (PM). Those held for the USMS service (TR) were about 17% of those in custody and had stayed on average about a year and 2 months. About 5.77% of men were charged as parole violators (PV), about 13.59% were sentenced on felony charges (SF) and about 0.85% were Writs or Holds (WH). Writs and holds had the longest average length of stay (LOS) of 913 days (2.5 years). About 38.08% of men in custody had stayed less than three months. About 33.35% stayed between three months and one year while 28.57% stayed more than one year. The median length of stay (LOS) for men in custody was 117 days. (Half the men in custody had been in custody less than 117 days.)

Most Serious Active Charge for Men in Custody



Those charged with Writ/US Witness stayed the longest on average (3 years); followed by those charged with Homicide/Conspiracy/Kidnapping (2 years); followed by those with In-Transit USMS/USDC commitments (1.2 years). The average length of stay for men in custody was 320 days. 12.59% of men in custody were USMS/USDC commitments with unspecified charges. Those charged with assault, aggravated assault, domestic violence; homicide, conspiracy, or kidnapping; , carjacking or first-degree burglary; weapons; parole or release violations; arson; and property crimes accounted for the most serious offenses of 71.48% of men in custody. 61.4% of men in custody were charged with a violent or dangerous offense per DC Code 22 Section 4501.

About Women in Custody

Majority of all women in custody were 18 to 40 years old. The average age of women in custody was 36 years. The majority of women in DOC custody claim District of Columbia residency.



Employment Status at Incarceration Women

About 62% of women in custody were unemployed at the time of incarceration. About 29% were employed and fewer than 1% were employed part time.





About 62.07% of women in custody had unresolved charges that were either felonies (PF) or misdemeanors (PM). 9.48% of women in custody were held for the USMS (TR) and had stayed about a year and 8 months on average, the longest of all. Those charged as parole violators (PV) were 3.45% of the women in custody. Those charged with sentenced felony (SF) charges made up 8.62% of the women in custody. Sentenced misdemeanants (SM) made up the remaining 15.52% of women.

Length of Stay (LOS) for Women in Custody

About 56.9% of women in custody had stayed less than three months. About 27.59% stayed between three months and one year while 15.52% stayed more than one year. The median length of stay (LOS) for women in custody was 84 days. (Half the women in custody had been in custody less than 84 days.)

Women charged with assault, aggravated assault, or domestic violence as the most serious offense were 41.38% of all women in custody. 9.48% of women in custody were USMS/USDC commitments with unspecified charges. Those charged with assault, domestic violence, homicide, conspiracy, or kidnapping; parole or release violations; arson or property crimes; robbery, carjacking or first-degree burglary; and weapons accounted for the most serious offenses of 76.72% of women in custody. 65.28% of women in custody were charged with a violent or dangerous offense per DC Code 22 Section 4501.

Those with In-Transit USMS/USDC commitments stayed the longest on average (1.6 years), followed by those charged with Writ/US Witness (approx. 1.1 year), then those charged with homicide, conspiracy or kidnapping (11.3 months). The average length of stay for women in custody was 197 days.

FY 2022 Releases by LOS for Men

The average length of stay to release for men was 106.17 days. Half of men who were released stayed fewer than 19.37 days, the median length of stay to release.

Of men who were released, 50.90% were released to the community. Another 22.25% were removed by the USMS to Northern Neck, USMS to federal facilities, or USMS GB. 17.98% were removed by all other jurisdictions.

FY 2022 Releases by LOS for Women



The average length of stay to release was 36.23 days for women. Half of all women who were released stayed fewer than 9.07 days, the median length of stay.

70.65% of women were released to the community, another 5.98% were released to treatment programs. 3.26% were removed by USMS, USMS GB or to Northern Neck by the USMS. 16.85% were released to other jurisdictions.
