## AUDIT FINDINGS

### **Narrative:**

The auditor's description of the audit methodology should include a detailed description of the following processes during the pre-audit, on-site audit, and post-audit phases: documents and files reviewed, discussions and types of interviews conducted, number of days spent on-site, observations made during the site-review, and a detailed description of any follow-up work conducted during the post-audit phase. On May 15, 2020, the Central Detention Facility (CDF) Washington D.C. and I, Carroll Parrish Certified PREA Auditor agreed on a contract to conduct their PREA Audit. The PREA Coordinator Cicily Harrington and I discussed the logistics and schedule for completing the audit. I informed her that another Auditor (Ms. Yvette McEachern) would be at the facility during the audit to assist with conducting resident and staff interviews. I informed her that I would be completing the audit report and that Ms. McEachern would be helping to complete interviews and that most of the interviews would be conducted with me.

It was understood that the audit was contingent upon COVID-19 outcomes. The facility cases were monitored and there were no reported cases at the facility. We decided that we would conduct the audit. It was understood that the auditors, staff, and detainees at the facility were required to wear face mask and practice social distancing in the facility. I submitted a completed notification with my name and PO Box number for the residents to contact me and forwarded it to the PREA Coordinator. The PREA Coordinator posted the notice in the detainees housing units and emailed pictures of the posting to me. I was informed that the facility was operating under emergency staffing (12-hour shifts) due to the Coronavirus 2019 and that some of the staff interviews would have to be conducted via Zoom.

The facility elected to conduct the PREA Audit August 10-12, 2020 and to use the Online Audit System (OAS) format. I completed an audit initiation form and submitted it to the OAS. The OAS approved the request and provided access to the system. The facility completed the Pre-Audit questionnaire and the OAS provided access to me on July 30, 2020. I reviewed facility policy and procedures.

On August 10, 2020, we arrived at the facility and had a PRE-Audit meeting with Warden Johnson, Deputy Warden Landerkin, PREA Coordinator, PREA Compliance Manager, and the Victims Services Coordinator. We completed staff introduction and explained audit expectations and methodology. Facility staff informed us that they did not house youthful offenders and they did not house female detainees.

A through tour of the facility was conducted with Deputy Warden Landerkin, PREA Coordinator Cicily Harrington, PREA Compliance Manager Courtney Savage and PREA Victim Services Coordinator Keisha Culbreth-Brooks. The following areas were visited and observed: all resident living areas, restrictive

housing, education areas, food service, facility operations, maintenance area, administrative area, resident laundry area, recreation, and common areas (day rooms), intake and Chapel. The auditors observed jail operations and asked probing questions as prescribed in the PREA Auditor Handbook. We also ensured that the proper signs were posted throughout the facility. We performed a system check of the inmate hotline. The victims advocate answered the phone within a minute. In addition, the message went to the PREA Coordinator and Compliance Managers telephone. The auditor observed if female staff were announcing themselves when they entered male housing. We also asked supervisors about how they made rounds probing to determine if unannounced rounds were being conducted. Supervisors clearly articulated that unannounced rounds are being routinely conducted. Staff logbooks validated that they are occurring. During the tour it was evident that female detainees and youthful offenders were not housed at the facility. We met after the tour and discussed our initial impression. We then conducted random and targeted staff interviews in the administrative area of the facility for rest of the day.

We conducted detainee interviews in the intake area on the second day of the audit. The population was 856 so we set up 30 detainees for interviews. 15 by random selection and 15 targeted. We had three transgender detainees selected. One refused. Two of the transgender detainees indicate that they feel safe. That they are provided equal programming and that they are educated about PREA and how to report any problems. One vision impaired detainee was selected by refused an interview. One cognitive impaired detainee was selected but refused an interview. One LEP detainee was interviewed through an interpreter and he indicated that he was ok and that he was educated about PREA and knew how to report any violations. We did not have detainees that met all the criteria, so we added more random detainees. 5 of the random detainees declined. The detainees all indicated that they were educated about PREA when they arrived. They all knew about the hotline and multiple ways of reporting PREA incidents. They were aware of the zero-tolerance policy and their rights. After we finished with detainee interviews, we continued to complete the targeted staff interviews. There were no residents who reported sexual abuse.

The six different interview protocols were used to interview staff. Staff interviewed were: Agency Head or designee (Warden), PREA Coordinator and Compliance Manager, Specialized Staff, and Random Staff. Random staff interviews of staff were scheduled through random selection from rosters provided prior to the audit.

Targeted Interviews were conducted with the following: Agency Head (Warden Johnson), Deputy Warden Landerkin, PREA Coordinator Harrington, PREA compliance manager Savage, PREA Victim Services Coordinator Keisha Culbreth-Brooks, Medical Staff, Chief Hammond Investigations, Case Management Carrington, Contract Administrator Renee Alexander, Training Manager Dr. Lynnita Thomas, Sane Staff, PREA Hotline Rep Jenae Williams, National Center for Victims of Crimes Advocate.

In conclusion, the auditors were allowed free access to all areas of the facility, had access to interview residents selected randomly and to see documentation requested. Posters were visible throughout the facility announcing the audit as well as how to contact the hotline. Staff made notification to the population when they were making rounds in their living areas. Cameras were placement was well thought out. All blinds spots were covered. The facility staffing plan was adequate. The staffing of the

camera viewing room was commendable. There were no letters received from the resident population. Documents reviewed for this audit included policy, institutional supplements, staff training records, Memorandums of Understanding, records, personnel information, housing unit logs, volunteer and contractual employee records, and training curriculums. ## AUDIT FINDINGS

### **Facility Characteristics:**

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. The Central Detention Facility (CDF/DC Jail) is in Southeast DC at 1901 D Street, SE. The current facility was opened in 1976. In July 2002, the United States District Court for the District of Columbia vacated the population capacity limit at the DC Jail imposed in the 1985 Campbell v. McGruder court ruling. In October 2007, the Executive Administration established a population capacity at the jail of 2,164. The daily population numbers are 1280. When the PREA Audit was conducted the facility had 857. The facility has one building with 18 housing units. They do not house youthful offenders or female inmates. One building has single cell housing and 17 have double cell housing in addition to the intake and release areas. They have no open bay/dormitory housing and 232 cells dedicated to inmates that require restrictive housing. The facility houses male inmates who are awaiting adjudication of cases or are sentenced for misdemeanor offenses. As a result of the National Capital Revitalization and Self-Government Improvement Act of 1997, sentenced felons are transferred to the Federal Bureau of Prisons.

The facility currently employs 1350 staff who may have contact with inmates. They have 823 uniform staff included in their staffing plan. They have an excellent camera system that is operational 24 hours a day. They have hired 101 staff in the last 12 months. They have established two contracts in the last 12 months and they 82 contractors authorized to enter the facility. They also have 93 volunteers who have contact with inmates, currently authorized to enter the facility.

The facility offers a variety of programs to inmates housed at the DC Jail. These programs include: HIV/AIDS Prevention, Education and Intervention Services; Individual and Group Counseling Services; Hispanic Life Skills; Book Club; Street Law; Literacy Education; Religious Services; Mental Health Adjustment; and Anger Management, among other life skills development and religious services. They provide medical and mental health services on site

The facility provides a consistent and efficient intake flow that captures all the required screening processes, including PREA screening and orientation. The facility provided information and evidence that their process has several safeguards that enable them to capture information from each detainee that enters the facility. The Central Detention Facility PREA operation was extremely impressive and could serve as a model for other agencies and facilities to follow. Command staff are professional and competent and have the leadership ability to get staff to perform at high levels in a challenging and complex environment.



## AUDIT FINDINGS

### Summary of Audit Findings:

A site visit for a PREA audit was conducted August 10th-12th , 2020 for the Central Detention Facility , which is under the jurisdiction of the District of Columbia Department of Corrections. The audit consisted of a tour of the facility, various interviews and documentation review.

The facility was under modified movement and activities due to the Coronavirus. All on the unit activities continued, which included groups, video visitation visits, phone calls, showers, and modified recreation. The inmates were allowed modified recreation which included a minimum of 2.5 hours of out of cell activity. Individual and small group religious services could occur on housing units. Medical services were occurring on the unit when possible and appropriate. All programs that could occur were allowed. We were allowed access to all areas in the facility but had to wear face mask and plastic shields. Inmates were provided tablets to help with education and other services that did not jeopardize security.

	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>The PREA Coordinator has been in contact with me on several occasions and has sufficient time dedicated to PREA Compliance. She lives PREA full time. She gets the meaning and purpose of the Act. Her agency also understands that this is what is needed to accomplish the mission of having a safe facility for the public, employees and detainees. She is in the hierarchy of the organization as indicated on the organizational chart with the director.</p> <p>Interview with the PREA Coordinator and the agency compliance manager presents clear evidence that they dedicate their time with PREA coordination and compliance. We conducted a system check with the inmate hotline and the coordinator received notification and she and the system worked properly. Moreover staff at the facility continued to indicate that the PREA Coordinator works above and beyond the call of duty. She continued to impress during the audit process with her knowledge and dedication to PREA. She works closely with the warden and upper level custody staff. The compliance manager is excelling too. She knows the facility and continued to demonstrate her commitment. Staff are knowledgeable due to the oversight of the Coordinator and Compliance Manager. As mentioned the facility has a full time PREA compliance manager too. She was asked about her time allowed and she said that she was mentored and given hands on training with the coordinator. She walked the facility with us and knew where the operations and management of the jail. She and the coordinator work hand in hand. They demonstrate team work. In my opinion they exceeded the standard that I have seen, managed and audited.</p>

115.12	<b>Contracting with other entities for the confinement of inmates</b>

	<b>Auditor Discussion</b>
	<p>The agency contract administrator indicates that there are a few inmates housed outside the facility. She indicates that they are given oversight in the same manner as the CDF. They had not had any incidents. There are two small facilities that are given oversight by CDF. They are in compliance with PREA. They are community correction facilities and are also under the guidance of the BOP.</p>

115.13	<b>Supervision and monitoring</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>I reviewed and was given a copy of the staffing plan. The facility has several dynamics that have to be considered. Still the compliance manager and coordinator indicate and provided detailed information that they have major input when it comes to staffing the post and operations in the facility. The plan is reviewed annually as prescribed in PREA policy. Each post is reviewed thoroughly. Previous problems and incidents are considered when redoing the plan. Camera placement and allocation is considered. The coordinator and compliance manager also work hard to find additional funding to improve. The facility develops and document, on a regular basis a staffing plan with adequate staffing levels. Also camera allocation is superior and complements that staffing plan and operation. I also observed the camera observation area. They have dedicated staff whose sole purpose is to monitor the cameras in the facility. Moreover thirteen staff are assigned to monitor all cameras continually during jail operations. Staff when questioned clearly articulated the process and system that is used to control security operations. The PREA component is not an after thought but is actually incorporated in jail operations and is a part of the culture engrained in staff operation and behavior.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	Policy prohibits the assignment of youthful offenders to the facility.

	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>Random staff indicate that they have received appropriate training on searches. During probing of staff the answers were consistent when they explained the search process. They also indicated that there is strong oversight by the compliance manager and coordinator that reinforces their behavior. In addition staff indicate that if they have questions they are free to call the compliance manager and coordinator because there is a strong control in place that monitors and ensures compliance. The training manager explained the training policy and process. She indicates that staff receive pre service, in service and spot training when needed to ensure that staff are consistent and aware of the search policy.</p>

	<b>Auditor Discussion</b>
	<p>CDF does not rely 011 inmate interpreters, inmate readers, or other types of inmate assistants except in exigent where an extended delay in obtaining an effective interpreter could compromise the inmate's, arrestee's, or resident's safety or the performance of first-response duties, or the investigation of the inmate's, arrestee's, or resident's allegations. The agency head designee explained the process for managing inmates with disabilities and limited English. There are several methods available to inmates to communicate with staff and agencies outside of the facility. In addition the inmate telephones have prompts and instructions that lead inmates to serves that will add them if they need interpreters or help with disabilities. There were two inmates selected that indicates that there are services that aid them in communicating with staff or outside agencies. They indicate that they are not having any problems that need to be reported but were aware that there are services that help them if needed. The facility uses interpreters to help detainees that need assistance. The telephone system also has prompts that help the detainees understand PREA and other facility procedures.</p>

	<p>We were informed that a through background check is always completed on new individuals coming into the facility and that PREA Coordinator and Compliance Manager and kept informed about the clearance of new staff before they are allowed into the facility. File review indicates that back ground checks are completed. In addition, the investigators indicate that a through check is completed and that all employees volunteers and contractual employees are vetted before being allowed into the facility.</p>

	<b>Auditor Discussion</b>
	There have been no new renovations. The tour did not show any recent renovations and the agency designee confirmed it. There have been no new cameras however the system in place far exceeds systems in other facilities. If new technology or cameras would be installed the PREA Coordinator would have major input.

	<b>Auditor Discussion</b>
	<p>The facility provides access to a victim advocate, and they have a qualified agency staff member, and also qualified community-based organization staff member. In the event of a problem the inmate is provided with supports through the forensic medical examination process and investigatory interviews and provides emotional support, crisis intervention, information, and referrals.</p>

	<b>Auditor Discussion</b>
	Investigative staff review and investigate administrative cases and take administrative action. Metropolitan Police Department conducts criminal investigations. The website is up to date and included PREA information and information about investigation responsibilities.

<b>115.31</b>	<b>Employee training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The facility mandates post test to ensure that staff understand the training content. The training specialist send coorespondence to ensure staff receive and acknowledge training. They maintain sign in logs from staff. Electronic documentation is maintained. The documentation is attached for further review.</p>

<b>115.32</b>	<b>Volunteer and contractor training</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The Moss group provided the training based on the service that they provide. The facility maintained documentation. Volunteers and staff are made aware of the agency's zero tolerance policy toward sexual harassment. Volunteer staff indicated that they were knowledgeable and responsible just like the permanent staff at the facility.</p>

<b>115.33</b>	<b>Inmate education</b>
	<b>Auditor Overall Determination:</b> Exceeds Standard
	<b>Auditor Discussion</b>
	<p>Intake staff were consistent about the inmates receiving training. PREA Auditors conducted interviews with inmates in the area and they confirmed that they all received training and information about PREA goals and mandates. Intake staff indicates that they consistently have all inmates trained expeditiously. The auditors did not find any incidents where residents' documentation was missing. Inmates when questioned all indicated that they received documentation and were provided with visual training at intake. All questioned were clear on PREA purpose, the expectations and more importantly zero tolerance policy.</p>

<b>115.34</b>	<b>Specialized training: Investigations</b>
	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>The agency staff are trained in investigations and are former police. Sexual abuse is handled as a crime and the Metropolitan Police Department (MPD) handle all sexual abuse cases. All allegations are vetted through the facility and are forwarded to MPD when required. Charles White investigator received training with the Metropolitan Police Department. The documentation is attached.</p>

	<b>Auditor Overall Determination:</b> Meets Standard
	<b>Auditor Discussion</b>
	<p>Conducted outside of facility. Medical staff was aware of how to preserve evidence but they work hand in hand with custody to provide immediate medical attention to the inmate in terms of life safety but will help facilitate the movement of the inmate to the appropriate outside hospital. They are no trained in conducting forensic exams. This is completed at outside hospitals. Medical staff confirmed when questioned the written policy. Specifically, we staff the medical area 24 hours a day. We have been trained to conduct investigations on detecting detect and assessing signs of sexual abuse, assault, and misconduct. We would preserve physical evidence of abused or inmates who report that they have been assaulted. We respond to victims of alleged sexual abuse, We ensure that a connection to a sane unit or person is established. Our training informs us to communicate and work with custody to facilitate the proper care and attention as prescribed in PREA.</p>

	<b>Auditor Discussion</b>
	<p>Inmates are not disciplined or threatened about answering questions. We want to provide a safe facility for staff and inmates and encourage them to report or let us know if they are having problems. answer: inmates are not disciplined or forced to give information if they don't want to. Inmates are informed that we care about their safety and that we want to help them and keep them safe. Question: Do you reassess an inmate's at risk level as needed due to a referral request, incident of sexual abuse or receipt. Yes, we provide follow up as prescribed in the standards. Inmates were asked if probing questions about previous incarceration and sexual abuse was asked and consistently they said yes. Staff were proud to demonstrate their compliance with PREA. Documentation provided evidence of assessment and re assessment. An objective screening tool is used at the facility. All ten criteria are utilized. A copy is attached.</p>

	<b>Auditor Discussion</b>
	<p>Staff are aware that we have to provide safety and provision for inmates that are transgender and intersex to take showers in peace and freedom. We also provide oversight to the areas were they take shower and we provide time so that they can take showers in peace. We always want to see things from a transgender or intersex inmates view. The old days of just locking a person in are over. We have to work to provide safety and security and we cannot discriminate. Again we consider health and safety of our residents. We consider health and safety first. We also want to provide equal programming for all residents and will not discriminate . . We make case by case decisions for inmates. Each person is unique.</p>
