- 1. **PURPOSE AND SCOPE.** To ensure provide procedures that will allow eligible inmates the opportunity to register and to vote by Absentee Ballot in the District of Columbia and federal elections while incarcerated.
- 2. **POLICY.** It is the policy of DOC to allow eligible inmates the opportunity to register to vote and to vote by **absentee** ballot.
- 3. **APPLICABILITY.** Eligible voters who are confined in a DOC facility shall be allowed to register to vote and to vote by absentee ballot on the DC Board of Elections Application for Absentee Ballot Form (Attachment A). Inmates housed in Community Correctional Centers shall be allowed to vote at designated polling locations.
- 4. **NOTICE OF NON-DISCRIMINATION.** In accordance with the D.C. Human Rights Act of 1977, as amended, D.C. Official Code § 2-1401.01 et seq., (hereinafter, "the Act") the District of Columbia does not discriminate on the basis of race, color, religion, national origin, sex, age, marital status, personal appearance, sexual orientation, gender identity or expression, familial status, family responsibilities, matriculation, political affiliation, genetic information, disability, source of income, status as a victim of an intrafamily offense, or place of residence or business. Discrimination in violation of the Act will not be tolerated. Violators will be subject to disciplinary action.
- 5. **PROGRAM OBJECTIVES:** The expected results of this program are that eligible inmates be allowed to register to vote and participate in the actual voting process by absentee ballot while incarcerated. Once released, they will also be permitted to vote as a result of their registration.

#### 9. **DEFINITIONS**

a. **Primary Elections-** A primary election is an election during which people who are registered with the major political parties select their party's representative, or nominee, to the general election. Primaries are held for only partisan offices. Only the Democratic, Republican, DC Statehood, Green, and Libertarian parties have qualified to hold primaries in the District of Columbia. Primaries in the District are "closed," which means that only voters who are registered with a party may vote in that party's primary election.

Contests for the following partisan offices are held in primary elections:

- 1) President and Vice President of the United States/Presidential Electors
- 2) Delegate to the United States House of Representatives
- 3) Mayor of the District of Columbia
- 4) Chairman of the Council of the District of Columbia ("the Council")
- 5) 4 At-Large Members of the Council
- 6) 8 Ward Members of the Council
- 7) Attorney General of the District of Columbia
- 8) 2 United States "Shadow" Senators
- 9) 1 United States "Shadow" Representative

b. **General Elections-** The general election is the final step in an election process. All public offices in the District of Columbia, including partisan and nonpartisan, are elected through the general election process. All registered voters, including independents may vote in the general election. Nonpartisan offices in the District include at-large and ward members of the State Board of Education, and Advisory Neighborhood Commissioners.

For partisan offices, nominees who either win their party's primary or are appointed by their party to serve as the party's candidate in the general election are listed on the ballot along with any independent or minor party candidates who have qualified for the ballot through the direct access nominating petition process. Nominees' party affiliations appear next to their names on the ballot; if a candidate is not registered with a political party, the word "independent" is printed next to his or her name. For nonpartisan offices, party affiliations do not appear next to candidates' names.

- c. **Special Elections-** A special election is an election that is held to fill a vacancy that occurs in an elected office between general elections.
- d. **Board of Elections ("Board" or "BOE")** The independent agency of the District government responsible for the administration of elections, candidate ballot access, and voter registration. The BOE consists of three active Board members, an Executive Director, a General Counsel and a number of support staff who run the day-to-day operations of the Agency.
- e. **Voting Coordinator-** DOC staff member selected by the Deputy Warden for Programs and Case Management to oversee the voting process for the CDF. CTF staff member selected by the CTF Warden to oversee the voting process (currently the Principal). This staff member is responsible for communicating with the BOE and relaying voting information to the CDF and CTF.

# 10. PROCESS TO REGISTER TO VOTE

- a. Case Managers will review each Intake inmate commitment and prior history to determine if the inmate is eligible to register to vote. If there are questions about eligibility to vote the Voting Coordinator shall be contacted as soon as possible. If the Voting Coordinator is not available the question shall be forwarded to the Board of Elections for a response at 202-727-2525.
- b. Those inmates who are eligible to register to vote will be given a Voter Registration Application Form (Attachment B) to complete. The Case Manager will review this form with the inmate to ensure that it is accurate and complete. The Case Manager will also initial and date the application in the designated location. This initial and date will verify to the BOE that the inmate registered on that date.
- c. If the inmate needs assistance completing the form the case manager will provide the assistance, or arrange for appropriate assistance to be given to the inmate.
- d. Once the Voter Registration Application is complete it shall be forwarded to the Voting Coordinator the same day. These completed applications are to be monitored at all times while in case management custody and are not to be left unattended. In the event the Voting Coordinator is not available, the applications will be hand delivered to the office of the Chief Case Manager.
- e. The Case Manager will complete a Voter Registration Agency Certification (Attachment J) which denotes that the inmate has registered to vote or he is refusing to complete the Voter Registration Application. This form is to be scanned into the inmate's electronic file and the original form is to be forwarded to the Voting Coordinator or designee. The inmate may keep a copy of this document if he/she chooses.

- f. Voter Registration Applications are forwarded to the Board of Elections on a weekly basis or within ten (10) days of registration with a Receipt for Delivery Form (Attachment C).
- g. Case Management staff is to ensure that Voter Registration Applications are available upon request.
- h. Inmates who want to vote in an election must complete and submit a Request for an Absentee Ballot (Attachment A) in order to vote at the CDF or CTF. Inmates who are housed in a Community Corrections facility can vote at their designated polling place.
- i. Prior to the election, the BOE will notify the DOC Voting Coordinator of the last day that an inmate can register to vote in an upcoming election.
- j. The BOE will notify the Voting Coordinator of the last day that an inmate can complete a Request for an Absentee Ballot. Once this ballot is completed, the case manager will forward the completed document to the Voting Coordinator. In the event the Voting Coordinator is not available, the applications will be hand delivered to the Office of the Chief Case Manager.

The following information will be given to inmates:

- 1) Information as to the last day they can register to vote in an upcoming election,
- 2) A request for an Absentee Ballot,
- 3) The date the voting will take place in the facility, and
- 4) Eligibility requirements and a Guide to Voting for Incarcerated and Returning Citizens pamphlet (Attachment D).

- k. The Voting Coordinator will ensure that an announcement concerning the voting process for an upcoming election is prepared for the Command Center staff to read at designated times. There will be scheduled and documented accounts of the Voting Announcement Skit (Attachment E) to be read over the Public Announcement system from the Command Center.
- The announcement will also be documented on the Voting Announcement Reading Notification Form (Attachment F) that must specify date, time and the name of the staff member conducting the announcement. Case Managers will ensure the announcement is heard in each housing unit.
- m. The Major or designee will ensure that the voting announcement is read at the designated times and that the reading at those designated times is documented. The signed verified reading document will be forwarded to the Voting Coordinator.
- n. The Voting Coordinator will be responsible for meeting with the Chief Case Manager and Case Managers to explain the process for the upcoming election for passing out a list of eligible inmates, distributing the Voting Flyer to be posted in English and Spanish (Attachment G), and answering questions relative to the voting process. The Voting Coordinator will meet with the Warden, Deputy Warden(s) and Major(s) to plan the actual voting process prior to voting.
- o. Special Elections: Only the inmates who live in the specific Ward shall be able to vote in Special Elections for a specific Ward. Information received from the inmate at intake concerning his/her residence will be used to determine those inmates assigned to a specific Ward. The Voting Coordinator will solicit assistance from the Chief of Strategic Planning and Analysis and the BOE to gather information concerning the effected wards for Special Elections and distribute that information to the case management staff. Case managers will notify eligible inmates and determine if he/she wants to vote in the Special Election. If the inmate does want to vote by absentee ballot, he/she must be registered and must complete the Request for an Absentee Ballot.

- 11. **VOTER REGISTRATION REQUIREMENTS:** If you are an inmate in the District of Columbia Department of Corrections facility and want to register to vote, you must:
  - a. Be a citizen of the United States;
  - b. Be a resident of the District of Columbia;
  - c. Not claim voting residence outside of the District of Columbia
  - d. Be at least 16 years old;
  - e. Not have been found by a court to be legally incompetent to vote;
  - f. In order to vote, you must:
    - 1) Maintain residency for at least 30 days prior to the election in which you intend to vote
    - 2) Be at least 17 years old
    - 3) Be at least 18 years old by the next general election;
  - g. In order to vote in a party's primary election, you must also:
    - 1) Be registered in that party at least 30 days prior to the election unless you are registering for the first time;
  - h. You <u>may</u> vote in DC elections if you are an inmate:
    - 1) Awaiting or on trial for a criminal offense
    - 2) Incarcerated for conviction of a misdemeanor offense; or
    - 3) A Parole Violator awaiting a hearing from the US Parole Commission

- i. You <u>cannot</u> vote in DC elections if you are an inmate:
  - 1) Incarcerated for conviction of a felony offense.

## 12. PROCEDURES FOR CONDUCTING VOTING PROCESS

- a. The Voting Coordinator will ensure that case management receives information as well as forms to distribute to the inmate population to prepare them to vote.
- b. The Voting Coordinator will meet with case management staff to ensure that they understand the entire voting process. Staff will be reminded that they cannot guide or direct an inmate to vote for a particular candidate nor can staff distribute any candidate's campaign information. Voter's Guides will be requested from the Board of Elections as soon as they are available and will be the only information that inmates will receive about candidates running for office.
- c. The Chief Case Manager will ensure that Case Managers post information, hold weekly Town Hall meetings, distribute and collect registration forms and requests for Absentee Ballots and that the collected documents are forwarded to the Voting Coordinator daily.
- d. The Chief Case Manager will ensure that all voting forms are collected from each case manager's office daily during the election period in the event a Case Manager is on leave.
- e. Once a date for the voting is set, the staff as well as the inmates must be notified of:
  - 1) The date the voting will take place,
  - 2) The requirements to vote,

- 5) Information on the candidates running for office
- f. Once inmates have registered and submitted their applications for the Absentee Ballot, the Voting Coordinators at DOC and CTF will receive all Applications for an Absentee Ballot from case management and forward the ballots to BOE. The Board of Elections will total the ballots to determine the number of inmates who will be voting.
- g. The Voting Coordinator and Majors/custody staff at DOC will meet to determine the best location(s) to conduct the voting process. Voting is held at the Law Library at CTF.
- h. Custody staff as well as Case Management staff will be notified of the voting locations.
- i. The night prior to the voting, the Voting Coordinator will ensure that the Major's office receive a census for each housing unit indicating the names of the inmates who will be voting.
- j. The Majors will ensure that the designated inmates are up, dressed and ready to be released to vote by housing unit by 9:00AM on the morning that the voting will take place.
- k. The Chief Case Manager will ensure that sufficient case management staff is assigned and available to assist in the actual voting process.

#### 13. **RESPONSIBILITIES**

#### a. Voting Coordinator shall:

- Maintain communication with the Board of Elections as well as Office of Returning Citizens Affairs and ensure sufficient forms, Voter Registration Applications, Applications for an Absentee Ballot are available for and forwarded to BOE as required.
- 2) Maintain all necessary information about the voting process.
- 3) Ensure Voting information is distributed and publicized via flyers, announcements and Town Hall Meetings.
- 4) Provide appropriate assistance to CTF and CDF staff concerning the voting process as well as ensuring that forms are completed properly.
- 5) Ensure the Warden is kept abreast of the Voting process specifically during the actual elections.
- 6) Ensure the Voting Institutional Access Memorandum (Attachment H) is prepared to inform CDF and CTF Staff Entrance as to who will be entering the facility to conduct the voting process from BOE as well as poll watchers and ORCA staff.

#### b. Chief Case Manager is responsible for:

 Ensuring that Case Management staff provides the opportunity for each eligible District of Columbia inmate to register to vote upon entry to the Central Detention Facility and the Correctional Treatment Facility. This process shall be documented on the Orientation Program Content Form (Attachment I) as well as on the Voter Registration Agency Certification Form (Attachment J) and signed by the Case Manager and the inmate.

- 2) Ensuring that each eligible inmate is afforded the opportunity to vote by absentee ballot and that the ballots are complete and forwarded to the Voting Coordinator in a timely manner.
- 3) Ensuring that the Orientation Program Content forms and the Voter Registration Agency Certification forms are scanned into the inmate's electronic file.
- 4) The Principal at CTF is responsible for ensuring that eligible inmates are afforded the opportunity to register and to vote. CTF is also responsible for documenting this process.

#### c. The Board of Elections (BOE) is responsible for:

- 1) Communicating with the Voting Coordinator or designated DOC and CTF staff and notifying DOC and CTF of upcoming elections and other pertinent information regarding voting in the District of Columbia.
- Ensuring that DOC and CTF receive Voter Registrations, Absentee Ballot Applications and the Voter's Guides (Attachment K) for distribution to inmates.
- 3) Notifying the Voting Coordinator or designated DOC and CTF staff as to whether inmates who have submitted a request for an Absentee Ballot are actually registered and eligible to vote in each election.
- 4) Keeping a list of all registered voters to include DOC inmates.
- 5) Arranging for pick-up of completed voter registration and absentee ballot applications.
- 6) Preparing paper absentee ballots only for those inmates who have submitted an absentee ballot request.

### Any District of Columbia registered voter may request an absentee ballot.

- 1. To vote by absentee ballot:
  - You must be an eligible registered voter; AND
  - You must live at the residence address that you provided on this application, or if you are a qualified military or overseas civilian voter, you must provide your legal U.S. residence address in the District of Columbia.

If you are not currently registered and you are requesting an absentee ballot by mail, you must mail a voter registration application with this request at least 30 days before the election for which you are requesting the absentee ballot. Within 30 days of an election, you may register in person at the Board's office.

# If you are voting for the first time in the District of Columbia, you <u>may</u> be required to include one copy of a form of identification. Acceptable forms of ID include:

- A current and valid photo identification or
- A current utility bill, bank statement, government check, or any other government document showing your name and current address.
- 2. Your absentee ballot application form must include the following:
  - Name of Voter
  - Current Residence Address of Voter
  - Mailing Address for Sending Ballot (if different from the current residence address)
  - Date of Birth of Voter
  - DMV-issued ID Number or the Last Four Digits of the Social Security Number
  - Signature of Voter (or mark, if voter is unable to sign)
- 3. Be sure to complete and SIGN the application. If you cannot sign your name, you may make a mark.
- 4. Your telephone number, fax number and email address are optional, however providing this data may expedite the processing of your request should we need to contact you about your application.
- 5. **Special Instructions for Military and Overseas Civilian Voters:** Please indicate your status as a military or overseas civilian voter and the preferred method of ballot receipt and communication. Only military and overseas civilian voters may receive absentee ballots by email or fax.

#### Remember:

- You must indicate for which election(s) you are requesting the ballot(s).
- Applications for mail absentee ballots must be received at the Board's address listed below at least seven (7) days before the election. Applications may be faxed to 202-347-2648.
- Your completed ballot must be postmarked not later than Election Day, and received no later than 10 days following the election in order to be counted.

## **Release from Custody**

If you requested an Absentee Ballot Application, but are released before your ballot is delivered, **you can still vote**! Just go to the polling place assigned to your residence address (If you don't know the location, you can check online at <u>www.dcboee.org</u>) and let the polling place official know that you did not receive your requested absentee ballot, and you want to vote a *Provisional ballot*.

# **Re-Registering to Vote**

When you are released from the correctional facility, you should re-register if your residence or mailing address changes so that election notices can be mailed to you at the correct address. Otherwise, your election material may be sent to the correctional facility and returned to the Board as undeliverable mail. If you registered to vote and were later convicted of a felony, simply re-register upon release.

# Why Vote?

• There may be candidates who support your ideals; and issues on the election ballot that may affect how citizens, inmates and their families live their lives – healthcare, minimum wage, prison reform, the environment and many other important topics. Inmates are encouraged to exercise their voting rights.

- District residents who have been P convicted of a felony and are no longer in jail, and meet the other voter registration requirements, are eligible to register and vote immediately upon release.
- Voting allows people to remain connected to their community, even if detained in jail.

# **Frequently Asked Questions**

#### Q. Can I vote if I'm in jail?

**A.** You may register and vote if you are in jail awaiting trial or serving time for a misdemeanor offense.

#### Q. How do I vote if I'm incarcerated?

**A.** Once registered to vote, you must apply for an absentee ballot. Election officials will hand-deliver your ballot within a week of Election Day.

# Q. Can I request assistance in voting my ballot?

**A.** Yes. Board officials are available to assist you with casting your ballot, if you request assistance.

# Q. Can I vote if I'm a convicted felon and on parole or probation?

**A.** Yes. Unless incarcerated, District residents can register and vote even if they are on probation or parole.

Many incarcerated citizens are not aware that they may be eligible to register and vote in District of Columbia elections. There are issues on the ballot that may affect inmates, their family or their community.

Department of Corrections staff provide voter registration applications for inmates to register to vote; and, the Board of Elections hand delivers their ballots before Election Day.

# **Voter Registration Requirements**

If you are an inmate in a District of Columbia Department of Corrections facility and want to register to vote, you must meet the criteria below:

- Be a citizen of the United States
- Be a resident of the District of Columbia
- Be at least 16 years old
- Have not been found by a court to be legally incompetent to vote
- Do not claim residence to vote outside of the District of Columbia

You <u>may</u> register to vote in D.C. elections if you are an inmate:

- Awaiting or on trial for a criminal offense
- Serving time for a misdemeanor offense

You <u>may not</u> register to vote in D.C. elections if you are an inmate:

• Incarcerated for conviction of a felony offense

# How to Register to Vote

The District of Columbia Department of Corrections is a District of Columbia National Voter Registration Act (NVRA) designated agency. You may register at the time of intake at the D.C. Jail or up fifteen (15) days before any election by completing a Voter Registration Application. You must provide either the last four digits of your social security number or your DMVissued identification number. When filling out the application, you may use either your DC home residence, or the address of the D.C. Jail or the Correctional Treatment Facility (CTF).

If you wish to vote in primary elections, you may register with one of four qualified political parties: Democratic, Republican, DC Statehood Green or the Libertarian party. You may register as an independent or with no party, or check "other" and register with a minor party to participate in general and special elections only.

Once your Voter Registration Application has been processed by the Board of Elections, a Voter Notification Card will be mailed to you stating that you are now registered. You may register to vote at any time, but to be eligible for an upcoming election, you must register at the agency at least 15 (fifteen) days before that specific election. The Department of Corrections' authorizing agent will submit the application to the Board for processing.

> The D.C. Board of Elections encourages eligible citizens to exercise their voting rights.

# Voting an Absentee BalloPage 2 of 2

If you think you will be in custody on Election Day, you must request an absentee ballot. You must be registered before applying for an Absentee Ballot.

You can vote if you have maintained residency in the District for 30 days before an election. Use the correctional facility address in the mailing address section on the application. Be sure to review your absentee ballot application before submitting it.

A Board of Elections' official will pick up your application from the agency and return it to the Board for processing.

# **Delivery of your Absentee Ballot**

DC Board of Elections' officials will handdeliver your absentee ballot in a secure envelope within one week of Election Day. You will be allowed to vote a secret ballot that will be sealed in a return envelope. BOE officials will be available to answer questions and assist you with marking or reading your ballot, if you request assistance. Remember to <u>sign</u> the back of the return Absentee Ballot Envelope to ensure your vote is counted. A Board official will collect the ballots and bring them back to the Board of Elections for counting along with the other absentee ballots.
